Recent	Shaney asked the group to share about their family		
successes/stories/highlights	engagement plans for the summer and recent family		
and obstacles/barriers to	engagement events. Oakridge is close to finalizing plans for		
success	their summer program and the summer youth employment		
	program. They are working on planning field trips and getting		
	teachers in place. They are engaging families through		
	orientation/registration events. They are also planning a		
	celebration for the end of the school year. They have also		
	been doing surveys for their local evaluation and engaging		
	parents as they are in the program. Des Moines Public Schools		
	shared that they did an art exhibit and a school-wide book		
	reading. It had a great turnout. Burlington shared information		
	about their family events. This time, they created official		
	invitations with an RSVP process which allowed them to follow		
	up with families they hadn't heard from. Each site had		
	different stations and the youth had input on what they		
	wanted to show their families. They provided a book or prize		
	for families who attended and visited stations. They shared		
	that it was nice to be able to make connections with families		
	outside of having conversations about difficult behaviors.		
	Council Bluffs Schools brought in sno-cone trucks for the youth		
	and families. For summer, they are in the midst of planning		
	with their community partners to offer new programming		
	during the summer. Storm Lake ties their family engagement		
	nights to the district's family nights. They provide book bags.		
	Vic also shared that he created a guide on the importance of		

	field trips (https://www.iowa21cclc.com/new-grantee-and-staff-transition). Vis also acknowledged the staffing shortages that have been caused from the pandemic. There are staffing incentives being offered to DHS-licensed programs if programs wanted to explore that option.
Other/Open Agenda/Updates	Vic reminded Committee members to code family engagement expenses correctly and to spend budgeted funds on family engagement events. This shows him that family engagement requirements are being met. He also encouraged Committees to make sure they are taking attendance, so there can be data about how many people were there.
